All 1<sup>st</sup> year General, Intellectual Disability and Mental Health Nursing students are required to attend on campus for <u>Garda Vetting on Wednesday 10<sup>th</sup> September</u> and <u>Induction on Thursday 11th September 2025</u>.

Room 2469. Monday-Friday 10.30am-12.00pm and 2pm-3.30pm.



#### Re: Student Nurse intake to HSE - Immunisation Screening for Clinical Placement

Dear Student,

Clinical placement in HSE premises is an important and necessary part of your nurse training.

The Department of Health Guidelines on Hepatitis B requires all staff considered to be at risk of contracting Hepatitis B to be vaccinated. As a healthcare worker, you may be at risk of contracting Hepatitis B. It is important that you have adequate protection against Hepatitis B. These vaccines will be provided by Occupational Health.

To ensure you are protected against infectious diseases, we require documented evidence of the following vaccinations:

- **BCG** Vaccination
- > MMR Vaccine x 2
- > Mengivac C
- > Tdap

(These records can be obtained from your local Community Care / Immunisations Office and / or your G.P.)

If you have received any other vaccinations, i.e. Hepatitis B / Hepatitis A, please send records.

You <u>MUST</u> submit your documented vaccination records to the HSE Occupational Health Department by induction day.

If you do not produce the above records, your Hepatitis B vaccination (which is strictly recommended for all healthcare employees) may be withheld. This may result in suspension of your clinical placement.
